World Water Day (22nd of March 2022)

Joint statement on the revision of the sustainable use of pesticides Directive (SUD)

The current obsolete agricultural model is showing its limits and represents a great deal of costs for the society: estimated at 2,3 billion euros. Agroecology has showed in several studies its benefits for agriculture in both economical and environmental dimensions.

The EU Commission has drafted a proposal for a Regulation on the Sustainable Use of Plant Protection Products, which seems to not be ambitious enough to meet the objectives of the EU Green Deal, the Farm to Fork and the Biodiversity Strategies.

Therefore, NGOs and CSOs are pushing the EU Commission to introduce a proposal that will drive towards agroecological food systems that protect biodiversity, ecosystems and human health. The undersigned organisations have proposed 10 more elements, that must be taken in account in the new proposal.

Gypsum: Stop overexploitation - promote gypsum recycling

The environmental network GRÜNE LIGA presented the results of a two-year project on natural gypsum mining in Germany in Bad Windsheim in northern Bavaria. Together with representatives of BUND Naturschutz in Bavaria, René Schuster, the national chairman of GRÜNE LIGA, visited the source of the river Aisch, which temporarily dried up as a result of neighbouring gypsum mining. Both associations stress that an expansion of natural gypsum mining must be prevented. To this end, recycling, alternative building materials and a resource-saving construction turnaround must be promoted. There is no basis for excessive designation of new gypsum mining areas in regional planning.

Background:

Large quantities of gypsum are produced in the flue gas desulphurisation plants (FGD) of coal-fired power plants, which have been mandatory since the 1980s.

As a result, gypsum consumption almost doubled from the initial five million tonnes to the current consumption level of about ten million tonnes per year. In the past two years, the GRÜNE LIGA has intensively discussed with important actors whether the coal phase-out must lead to a massive development of new gypsum mines. The 40-page report "Gypsum: Raw Material and Habitat" summarises the results of interviews, expert discussions, excursions and two public conferences with stakeholders from industry, research, administration and civil society. The report was presented for the first time in one of the affected mining regions on 1 March 2022.

#RED4Nature: Change EU policy for renewable energies- Together we can save the climate AND nature!

It is time for the EU to revise the Renewable Energy Directive (RED). This is the opportunity to push for an EU energy policy that excludes environmentally damaging renewables and addresses both climate change and biodiversity loss. The RED defines which forms of renewable energy can be used to achieve the 100% renewable energy target.

The #RED4Nature campaign is a broad advocacy strategy that calls on EU decision-makers to align renewable energy targets with the nature conservation goals of EU environmental legislation and the 2030 Biodiversity Strategy. It proposes an alternative, nature- and climate-friendly energy solution. An appropriate RED should include, among other things, prioritising the use of renewable energy with less impact on biodiversity, modernising and decentralising the energy grid and incentivising building modernisation, as well as improving the electrification of the energy system by upgrading existing infrastructure and extending it to rural areas.

The recently launched #RED4Nature campaign aims to show that there are energy solutions that can address both the climate and environmental crises. In order to put pressure on EU decision-makers to vote in favour of relevant legislative changes to the RED, we need a broad alliance of civil society to support the demands. The aim is to raise visibility around the #RED4Nature proposal and spark a discussion about solutions that work - and what many NGOs are already doing. We are also happy to support events at national level that can extend this message to relevant decision-makers in different EU countries and beyond the Brussels bubble. Increased cooperation between the Canoe-Associations

Just in time for the new season, the German Canoe Federation (DKV), representing the recreational canoe sport, and the Federal Canoe Association (BV Kanu), representing the commercial canoe providers, have agreed on a far-reaching cooperation regarding training recognition and collaboration. The core element of the cooperation agreement is the full mutual recognition of training levels and training courses. This will enable a greater exchange of knowledge between the associations and improve the utilisation of training courses.

Both associations are very concerned about respectful behaviour in and with nature. After all, it is important to maintain access to the waters for people so that future generations can also experience nature in Germany as intact as possible and be able to move around in it. The DKV and BV Kanu hope that this initiative will lead to a further spread and recognition of the European Paddle Pass EPP-D in Germany.

UN 2023 Water Conference: Global online Stakeholder Consultation

In the framework of the next UN Water Conference (22nd - 24th of March 2023) and pursuant to the <u>resolution 75/212</u> of the General Assembly, , the UN General Assembly has called for a Conference on the Midterm Comprehensive Review of the Implementation of the Objectives

of the International Decade for Action "Water for Sustainable Development" 2018-2028, which will be held in November 2022. The Member States and the various stakeholders must submit proposals on possible themes of Interactives Dialogues (five at all, taking place parallel to the plenary meetings) until the 10th of March 2022.
